In accordance with the Maharashtra Government Extraordinary Notification No.232 published on 05/07/2018, Government of Maharashtra vide Government Resolution Higher and Technical Education Department No. Sankirn-2019/(C.R.06/19)TE-5 dated 06/02/2019, Director, Technical Education is the Competent Authority for implementation of all the activities related to admission of Diploma Courses under the purview of Directorate of Technical Education, Maharashtra State.

This Notice is being issued for Online Registration & uploading of documents, Documents Verification and Application Form Confirmation for admissions to First Year of Three Year Duration Full Time Diploma Engineering and Technology programs in institutes where such quota is sanction by All India Council for Technical Education, New Delhi (AICTE) for the Academic Year 2022-23 in the State of Maharashtra. This notification is Only for **Overseas Citizen of India (OCI)/ Persons of Indian Origin (PIO), Foreign National (FN) Students and the Children of Indian Workers in Gulf Countries (CIWGC) candidates.**

Process of application: The Candidate shall register online, fill & submit online application form and upload the required documents from anywhere through the computer/smartphone connected to internet and he/she need not have to visit personally for verification and confirmation of the application form. His/her application & documents shall be verified and confirmed by the designated E-Scrutiny Center through online mode.

Aspiring candidates are informed to read the Rules, process and instructions given in the Information Brochure carefully. The Information brochure is published on <https://poly22.dte.maharashtra.gov.in> for download.

Eligibility Criteria for Admission

Overseas Citizen of India (OCI)/ Persons of Indian Origin (PIO), Foreign National (FN) Students and the Children of Indian Workers in Gulf Countries (CIWGC) candidates.

1. Passed 10th Std./ SSC examination or its equivalent, with at least 35% aggregate marks.
2. Any other criterion declared from time to time by the appropriate authority as defined under the Rules.

Important Note:

1. The term "Aggregate marks" is defined separately for State Board/ICSE and CBSE candidates in the Information Brochure.
2. In case the result of the candidate is given in terms of grades, such candidates are required to submit the graded result into the equivalent marks authorized from the concerned Institute /Board. The eligibility shall be decided on the basis of equivalent marks.

Online Registration for Admission: -

1. The candidates should apply online on <https://poly22.dte.maharashtra.gov.in> as per schedule.
2. Candidates are required to pay application fee as given below only by online mode through **Credit Card/ Debit Card/ UPI/ Net Banking** (No other mode of payment shall be permitted). Application fee paid is non-refundable.

Interested candidate shall approach directly to the respective Institute for admission where such quota is granted by AICTE. However, Directorate shall publish the list of such registered & eligible candidates separately on website.
3. List of Institutes and courses having approval from AICTE for AY 2022-23 under OCI/PIO, FN, CIWGC quota is attached in Annexure-A.
4. These seats shall be filled in by the institution on the basis of Inter Se Merit of candidates. The procedure of Inter-se-Merit is as given in Rule 8 of the Information brochure.
5. Candidate shall produce the relevant & valid documents to substantiate the claim made in the application form. In case of non submission of the relevant documents, the candidate shall lose such claims made in the application.
